8. Approval of the Agenda

10.Capital Requests: Rucker presented a request to purchase 14 document scanners for a total amount of \$6,019.13.

Motion made by Watson, supported by Johnson, to approve the purchase of 14 document scanners in the amount of \$6,019.13 to be paid from Major District Project Fund. Motion carried.

11. Notary Services & Change to Fines & Fees Policy

Request to amend the Fines and Fees Policy by adding a Notary services fee of \$5/page and a Send/Receive Fax fee of \$1 for each page sent, and \$0.50 for each page received.

Motion by Watson, supported by Gordon, not to charge for Notary Service, and to approve the proposed fees for fax services.

12.Strategic Planning Consultant

The board reviewed and discussed proposals from several vendors to provide strategic planning services to the BDL. Key factors in the discussion were proximity (e.g., companies from or near Michigan), library knowledge and experience, and cost. The deciding factor was the BDL's past history of positive experiences working with the MCLS.

Motion by Watson, supported by Clemens, to approve the bid from MidWest Collaborative Library Services (MCLS). Motion carried.

13.Staff Training: October 9 & 10, 2017

The Director requested approval to close the Coldwater Branch for two consecutive days of staff training on a variety of topics.

Motion by Watson, supported by Gordon, to approve closing the Coldwater Branch on October 9 & 10, 2017 for staff training. Motion carried.
