Dear Ken:

Thank you for your recent letter, giving information to be inserted in your club bylaws.

We have made all of the necessary insertions, Ken, but I am wondering if the five-mile radius you mention as the territorial limits of the Coldwater Club will overlap the territory assigned to the Bronson club. The maps we have here in the office are on such a small scale that we cannot determine definitely that the limits of the two clubs do not conflict. In checking our files, I find that the territory of the Bronson club (Southwest Townships of Branch County, namely, Noble, Bronson, Matteson, Sherwood, Union, Batavia, Bethel and Gilead) was released by your own club in April of 1944, the territory previously assigned your club having been all of Branch County. I assume you are familiar with these facts, Ken, and we are approving your bylaws, with the understanding that the territorial limits given therein do not conflict with the territory of the Bronson club. If they do, however, I trust you will let us know promptly. One copy of the approved bylaws are enclosed for your files.

As soon as we receive the bylaw amendment which I sent you on October 28, resolution indicating the desire of the club to become incorporated, and copy of your proposed Articles of Incorporation, we will be in a position to send you official consent to proceed with the filing of your papers. If we can assist in any way, please do not hesitate to write.

Sec. 2 -- "confined to a radius of 5 miles of the

City of Coldwater in Branch County.

Art. VI Sec. 1--Officers of the Club shall be President, The Immediate Past President, 1st. Vice President and 2nd. Vice President, a Treasurer and a Secretary.

Sec. 3 Part B
There is also to be a 2nd. Vice President to assist the President in his duties and to help the Ist. Vice President in directing the committee work.

Art. X Sec. 2 "The Annual Meeting of the club shall be the First regular weekly meeting in November.

Art. XV Sec. 1 The Membership Fee shall be \$15.

Sec. 2 The Annual Tues shall be \$10

I believe this covers all of the necessary provisions of our club. Sorry to have neglected this in the last letter.
