- 1. Reports from Central & Branch Liaisons:
  - 1. <u>Algansee Branch:</u> Mills reports.
    - 1. Our patrons read 45,000 pages, a little less than Sherwood, but we all did a good job during *March is Reading* month.
    - 2. We gave out bookmarks for National Library Week and talked to patrons about how important libraries are.
    - 3. The Annual Friends of the Library gathering is Tuesday, April 21<sup>st</sup> at the Quincy library.
    - 4. We have had a young lady volunteering at the library doing odd jobs.
    - 5. As soon as the weather warms up, we will be building bird houses with adults and children.
  - 2. <u>Bronson Branch:</u> Eash reports.
    - 1. We had a small group attend the *One Book, One County*. We watched the movie and had snacks.
    - 2. We had an adult workshop, where we made stepping stones.
    - 3. We showed our last *Friday night movie* until the Summer Reading Program starts. There were 43 attending.
    - 4. We had the Puppet Workshop, but the actual puppet show will be held the first week in May.
    - 5. We are having a bookmark contest during National Library Week.
    - 6. The Bronson Garden Club came and cleaned out all of the flower beds around the library.
    - 7. The Friends have a meeting Tuesday, April 21<sup>st</sup>. They are also having a rummage sale and book sale.
    - 8. On May 16<sup>th</sup> the Friends are having a Nelson's Chicken BBQ and their huge book sale.
    - 9. Building Project: Soil borings have been done. Wednesday the Building Committee is meeting with the architect.
    - 10. Capital Improvement Request: Bronson would like the board to approve the purchase of a projector, DVD player, speakers and an extra bulb for \$1684.15. <u>Motion made by Clover supported by Gay, to spend \$1,684.15 from Bronson's Capital Improvement fund for a projector, DVD player, speakers and an extra projector bulb. Motion carried.</u>

- 3. <u>Coldwater Central Branch:</u> Berg reports.
  - <u>April is National Poetry Week and Young People's Poetry Month:</u> Fliers were sent to the schools to encourage children to write poems and have them displayed at the library. There will be a winner from 3 different age groups. The winners will receive 2 tickets from the local movie theater and a \$10.00 gift certificate from Taylors Books & More. One of the tables in Kidsplace is covered with white paper and everyone is encouraged to create a poem on it. There is also a basket on the desk in Kidsplace for people to write poems. If they put their poem in the basket, it qualifies them for a drawing. The prizes are poetry books.
  - 2. <u>Homeschool Group</u>: For the month of April, the homeschool group is researching birds and building birdhouses. The last Wednesday of the month the children will give a report on the bird they chose to research and will share their birdhouse creations.
  - 3. <u>Story Hours:</u> We have 4 story hours for children ages 2 6 and lap time for little tots ages 6 months to 2 years.
  - 4. <u>Tech Services:</u> Sandy, Stephanie and Jeanne all attended a catalog training last week.
  - 5. <u>Adult Services:</u> Nola Baker has scheduled an author to visit during Michigan Week. Michigan Week is May 16 - 22<sup>nd</sup>.
  - 6. <u>Staff Room Updates</u>: The staff room has been painted and continues to be updated. Baker will be going to Longstreet's later this week to pick out table and chairs.

- 5. Quincy Branch: Frick reports.
  - 1. Mid-West Fire Protection serviced the fire extinguishers.
  - 2. Quincy Library's Annual Township report was presented at the April 7 meeting.
  - 3. Quincy computer use is pretty constant during each day.
  - 4. Stevens Puppets were at Quincy during National Library Week 45 attended..
  - 5. An Open House is being planned for Friday, May 22 during the Lincoln train festivities. The community will be invited to view our newly restored GAR flag.
  - 6. Central Elevator installed the two safety space guards on both elevator doors Friday, April 3.
- 6. <u>Sherwood Branch:</u> Mills reports.
  - 1. March is Reading month went quite well. We had challenged the Algansee branch patrons to see who could read the most pages for the month. Algansee patrons read 45,000 pages and Sherwood patrons read 46,120. The Sherwood adult patrons had their names in a drawing for a gift basket for every 500 pages they read and the children were elegible for a pizza party with Wii games. There were 8 adults that read over 5,000 pages. The winner of the gift basket was Marilee Wagar. The basket consisted of assorted chocolates and hard candy, coffee & tea, a coffee mug, a copy of Anatomy of a Murder, a crossword puzzle book and other small items.

The carpet that is being replaced is original with the addition (30 years). Cherry states concern of carpet on the stairs showing wear and would like to find out if there is a warranty and if so, is the wear considered excessive. Mills will check on this and get back with the building committee before the next board meeting. The board also discussed having the carpet cleaned on a regular basis. <u>Motion made by</u> <u>Gay, supported by Frick to accept the bid from Willowbrook Interiors for \$66,517.45 to do the renovations throughout the Central Headquarters. Motion carried.</u>
