



- I would like to thank all library staff involved in planning events and support for our Summer Reading Program. It's underway and things are really hopping! This wouldn't be possible without the concerted efforts of the Branch Managers, Linda Dull, Kimberly, Jessica, and everyone else who works so hard behind the scenes to make the magic happen. And many thanks to all the great community sponsors helping to fund the fun!
- I joined a Library of Michigan task force for evaluating the data that LM collects on libraries in the state, as well as how that data are collected, as well as other ways of using this data for planning programs and initiatives. This committee will meet every 2 months and will make recommendations to changing how our State Aid report collects data.
- There is a State-level group called the Trial Court Funding Commission (TCFC) that is looking into reforming the way Michigan trial courts are funded. Among other changes this Commission is recommending using penal fines, guaranteed for libraries since the the first Michigan Constitution of 1835, to fund reforms to the trial court system. The TCFC's final report on the matter is due in September, though their interim report from April is available now online at <http://publicsectorconsultants.com/wp-content/uploads/2019/04/TCFC-Interim-Report-FINAL-VERSION-FOR-CONTENT.pdf>. It varies from library to library, but at BDL penal fines typically comprise 10-15% of annual revenues. Anyone reading this who feels strongly about the potential ramifications of the TCFC's recommendation is encouraged to contact their legislator and share their opinion.
- The two positions authorized last month to be filled have been advertised online and in local print media. We have set a deadline of June 21 for accepting applications, and will be considering internal as well as external candidates.
- Cross-training among the management team continues. It's a slow process with all the other changes going on at this time, on top of Summer Reading. But we'll get there.
- I continue to evaluate HR and timekeeping software and hope to have a final recommendation soon.

Only 35 libraries were eligible to receive a kit from the Library of Michigan and the Bureau of Services for Blind Persons and we are very pleased that Branch District Library was selected! - *A Universe of Stories: Summer Reading Program 2019* is live! BDL Patrons began logging on June 3 and will continue to log until July 26. For the first time, all 6 branches are beginning and ending the summer reading program at the same time and as a district we are offering the same grand prizes at all of our branches.
